## **Requirements for EETS Providers**

Conclusion of an agreement between the EETS provider, GTC and Intertoll Polska Sp. z o.o. (A1 Motorway Operator) ("Agreement").

## **Terms for concluding Agreements for the EETS area**

To pass successfully the accreditation procedure by an EETS provider.

The Agreement must be approved by the Minister responsible for transport.

An EETS provider is responsible for the suitability and correctness of the technical information.

An EETS provider is responsible for obtaining and holding any required authorizations.

An EETS Provider shall bear the costs of modifying the Toll Collection System ("TCS") software.

An EETS provider is obliged to update the so-called "white list" of authorized vehicles.

An EETS provider receives a fee for the costs of operating the EETS service in the form of an agreed discount calculated from the net prices applicable at Toll Collection Points.

Electronic invoices issued by GTC on the first business day after the end of the month will include the discount and will be payable within 21 days.

An EETS provider shall provide GTC with a bank guarantee in the amount and with the content agreed between the EETS provider and GTC.

An EETS Provider may be charged to GTC in the event of a low transaction volume using the EETS Provider's Service.

The remaining terms of cooperation will be specified in the Agreement

### **Accreditation procedure**

1. An EETS provider contacts GTC with a proposal to cooperate in the EETS service at the EETS area
2. Conclusion of non-disclosure Agreement
3. An EETS Provider's system is verified with regard to the Technical Conditions
4. Conclusion of an Agreement and delivery of a bank guarantee to secure receivables
5. After signing an Agreement, an EETS Provider and the Operator confirm that the Toll Collection System (TCS) and the EETS Provider's system cooperate with each other
6. Before the launch of an EETS service, a test will be carried out with an EETS Provider
7. After the test is completed, a protocol will be drawn up
8. By signing the protocol, an EETS Provider's service is ready to be launched in the EETS area
